Getting started with IntelliCorp

1. Go to www.intelicorp.net and click on Sign Up Today. You will be required to enter a "Promotion Code" on the Contact Information page. (Important: Your Promotion Code is **NIF**)
2. After completing the first page, you have the option to continue or receive a call to answer your questions.
3. The second page is the Credit Authorization Form. If you do not fill this out online you may fax or e-mail it to IntelliCorp.
 - All we require is a name and phone number of each bank and trade reference, no account numbers are required.
 - Trade references are any vendor you do business with (ex: office supplies, insurance, credit card, utilities, etc.).
4. As part of the activation/validation process, a photocopy of one (1) of the following documents must be submitted to IntelliCorp or faxed to 216-450-5241.
 - A copy of a Business License, Vendor License -or-
 - A pre-printed formal government document containing your EIN or Tax ID number (ex: 501c3, 940, 941 Form, SS4, IRS Certificate, etc)
5. Once all of the information is received by IntelliCorp, it will take approximately 24-48 hours to activate your account. Once the account is activated you will receive an e-mail containing your User ID and password.
